Introduction

The National Child Abuse and Neglect Data System (NCANDS) is an initiative of the Children's Bureau in the Administration on Children, Youth and Families, the Administration for Children and Families within the U.S. Department of Health and Human Services (HHS). NCANDS was established as a voluntary, national data collection and reporting system to comply with 1988 Child Abuse Prevention and Treatment Act (CAPTA) amendments.

During 1996, CAPTA was amended to require all states that receive funds from the Basic State Grant program to work with the Secretary of HHS to provide specific data, to the maximum extent practicable, about children who had been maltreated. Subsequent CAPTA amendments added data elements, many of which are reported by states to NCANDS.

NCANDS data are published annually in the Child Maltreatment report. The most recent edition and other reports dating back to 1995 are available on the Children's Bureau website at <https://www.acf.hhs.gov/cb/research-data-technology/statistics-research/child-maltreatment>.

With the assistance of WRMA, Inc., a successful federal-state partnership is the core component of NCANDS. Each state designates one person to be an NCANDS state contact. The NCANDS state contacts from all 52 states, including the District of Columbia and the Commonwealth of Puerto Rico, work with the Children's Bureau and the NCANDS Technical Team to uphold the high-quality standards associated with NCANDS data.

Reporting Year

The NCANDS reporting year is based on the Federal Fiscal Year (FFY), or October 1 through the following September 30.

Reporting States

Each of the 50 states, plus the District of Columbia and the Commonwealth of Puerto Rico, may submit two data files each year:

- Child File contains case-level data
- Agency File contains aggregate-level data

In prior years, states that were not able to submit case-level data in the Child File

submitted an aggregate data file called the Summary Data Component (SDC). Because all states now have the capacity to submit case-level data, the SDC was discontinued as of the 2012 data collection.

Overview of the NCANDS Data Collection and Submission Cycle

States submit case-level data by constructing an electronic file of child-specific records for each screened-in report of alleged child abuse and neglect that received a Child Protective Services (CPS) response. Each state's file only includes completed reports that resulted in a disposition (or finding) as an outcome of the CPS response during the reporting year. The data submission containing these case-level data is called the Child File.

The Child File is supplemented by agency-level aggregate statistics in a separate data submission called the Agency File. The Agency File contains data that are not reportable at the child-specific level and are often gathered from agencies external to CPS. States are asked to submit both the Child File and the Agency File each year.

Upon receipt of data from each state, a technical validation review is conducted to assess the internal consistency of the data and to identify probable causes for missing data. In some instances, the reviews concluded that corrections were necessary and the state was requested to resubmit its data. Once a state's case-level data are finalized, counts are computed and shared with the state. The Agency File data also are subjected to various logic and consistency checks.

Overview of the Child File Record

Each record in the Child File contains information about a child associated with a report of alleged child abuse or neglect. All of the data elements in the record are grouped into these data sections:

- Report Data (fields 1-13) contains the two identifying fields (submission year and State ID) and general information about the report. The first identifying field for the record is the Report ID. The second identifying field for the record is the Child ID. All remaining fields in the report data section are attributes related to the Report ID. If a report involves multiple children, the report data fields, with the exception of the Child ID, are

identical on each record containing the same Report ID. For example, if there were three children in the report, the data in the entire report data section would be identical for all three child records, except for the three different Child IDs. Data in other sections may vary.

- Child Data (fields 14-25) contains general information about the specific child in the record. All fields in this section are attributes related to the Child ID. States submit data for all data sections through the 'Services Provided' section (fields 1-85) and for 'Additional Fields' (143-148). Data for the 'Perpetrators' section (fields 86-142) is submitted only if the child in the record is a substantiated or indicated victim.
- Maltreatment Data (fields 26-34) includes information about maltreatment types and maltreatment disposition levels. Up to four allegations of maltreatment are coded with the corresponding decision regarding the allegation. The field measuring maltreatment death is also included in this section as it is a contributor in determining the child victim status. There is no data in this section indicating the severity of maltreatment.
- Child Risk Factors (fields 35-43) contains data about the child's characteristics or environment that may place the child at-risk for maltreatment. This includes alcohol or drug abuse, diagnosed physical disabilities, or learning and behavioral disorders.
- Caregiver Risk Factors (fields 44-55) contains data about the child's caregiver characteristics or environment that may place the child at-risk for maltreatment. This includes domestic violence, substance abuse, financial problems, housing, and more.
- Services Provided (fields 56-85) contains information about services that are provided for the child or family. Post-response (post-investigation) services are reported to NCANDS if they were delivered between the report date (date the report was received) and up to 90 days after the disposition date. For services that began prior to the report date, if they continued past the report disposition date this would imply that the investigation or alternative response reaffirmed the need and continuation of the services, and they are reported to NCANDS as post-response services. Services that do not meet the definition of post-response services are those that (1) began prior to the report date but did not continue past the disposition date or (2) began more than 90 days after the disposition date.

- Perpetrator Data (fields 86-142) contains information about perpetrators of maltreatment. Up to three perpetrators per child may be reported. If the child was not found to be a victim of maltreatment, the perpetrator data section is left blank. The four perpetrator maltreatment fields for each perpetrator are linked to the four sets of maltreatment types and disposition level fields reported for the child victim (fields 26-34).
- Additional Fields (fields 143-148) contains any new fields that were added to the Child File subsequent to its creation in 2001, including derived variables.

Please note that WRMA, Inc.'s codebook includes a section 'Staff Data' (fields 86-87) since it is collected by the states, including identifier information about the CPS worker and the CPS worker's supervisor who were associated with the child on the date of the report disposition.

However, those data elements are not included in this codebook or data files since that information is not distributed for secondary analysis. As previously noted, there may be other field names and properties in the WRMA, Inc. codebook that differ from those in this codebook.

Definition:

The submission year is the Federal Fiscal Year (FFY) 12-month period. The FFY is from October 1 through September 30.

The year of data submission is based on the **report disposition date**. All report disposition dates fall within the submission year. The report date may have occurred in a previous fiscal year.

All records have the same year in this field.

#2 State or Territory

Variable Name: StaTerr

Variable Label: State or Territory

Definition:

The U.S. Postal Service two-character abbreviation for the state or territory submitting the Child File. In the NCANDS Child File, the District of Columbia and the Commonwealth of Puerto Rico have the same status as states.

#3 Report ID

Variable Name: RptID

Variable Label: Report Identifier (encrypted)

Definition:

A unique identifier assigned to each report of child maltreatment.

This identifier is not the original state-generated report identifier, but is an encrypted version assigned by the state for the purposes of the data collection. The Report ID is unique within the state, only used for a report once and never used again. A report can have more than one child associated with it. Thus, the same Report ID can appear in more than one record in a year.

#4 Child ID

Variable Name: ChID

Variable Label: Child Identifier (encrypted)

Definition:

A unique identifier assigned to each child.

This identifier is not the original state-generated child identifier, but is an encrypted identifier assigned by the state for the purposes of the Child File data collection. The Child ID is unique within the state, only to be used for a single child and never used again. This allows for a child to be uniquely identified in different reports within the same year and across different reporting years (with some limitations – see NCANDS User’s Guide: Analytic Considerations).

#5 State/County FIPS Code

Variable Name: RptFIPS

Variable Label: State and County FIPS Code

Definition:

The combined state and county Federal Information Processing Standards (FIPS) code of the jurisdiction to which the report of alleged child maltreatment was assigned for a CPS response. It may or may not be the child's county of residence.

The first two characters are the state code; the last three are the county code.

If a county has less than 700 records, then county FIPS codes are masked (i.e. set to 000) for all records from that county.

#6 Report Date

Variable Name: RptDt

Variable Label: Report Date

Definition:

The month, day, and year that the responsible agency was notified of the suspected child maltreatment referral. This is the date that the report of maltreatment was made. If a state combines several allegations into one report, the date of the report is the date of the initial allegation. The determination as to whether additional allegations are considered part of the original report or whether they are considered a new report is left to each state's procedures.

To help assure confidentiality of the data, this date has been rounded to either the 8th or the 23rd of the month. All other dates in this data are then similarly adjusted by the same number of days to maintain the timespan between all dates.

Date fields are in the “yyyymmdd” format.

#7 Report Time

Variable Name: RptTm

Variable Label: Report Time

Definition:

The hour and minute of the report date when the responsible agency was notified of the suspected child maltreatment referral.

The Report Time is the time of the day that is specified as the Report Date. If the Report Time is unknown or missing, the state leaves this field blank.

This variable was not reported prior to fiscal year 2013.

Time fields are in the “hh:mm” format.

#8 Investigation Start Date

Variable Name: InvDate

Variable Label: Investigation Start Date

Definition:

The date when CPS first had face-to-face contact with the alleged victim of child maltreatment. If this face-to-face contact was not possible, the date would be when CPS initially contacted any party who could provide information essential to the investigation or assessment.

This date is adjusted so that the interval between it and the report date is preserved after the report date was rounded to either the 8th or the 23rd of the month.

Date fields are in the “yyyymmdd” format.

Variable Label: Investigation Start Time

Definition:

The hour and minute when CPS first had face-to-face contact with the alleged victim of child maltreatment.

The Investigation Start Time is the time of the day that is specified as the Investigation Start Date.

If this face-to-face contact was not possible, the time would be when CPS initially contacted any party who could provide information essential to the investigation or assessment.

This variable was not reported prior to fiscal year 2013.

Time fields are in the “hh:mm” format.

Definition:

The category or role of the person who made the report of alleged maltreatment.

This is the primary source of screening information for the initial report. If multiple sources are collected by the state, the initial source is reported in this field.

#11 Report Disposition

Variable Name: RptDisp

Variable Label: Report Disposition

Definition:

The final determination (disposition) resulting from the CPS investigation or assessment about whether an alleged maltreatment occurred. The report disposition reflects the most severe maltreatment disposition of all allegations on the full report (which can encompass multiple children), therefore, there may be a child on the report who only has unsubstantiated maltreatment even if the overall report (e.g. RptDisp) is substantiated.

“Substantiated” or “Indicated or Reason to Suspect” means that at least one child on the report was found to be a victim.
